

# Camden welcomes new ice cream traders



Camden Council piloted an Ice Cream Scheme designed to achieve several positive outcomes using street trading licence requirements in line with the London Local Authority Act 1990 (as amended) in 2019.

This year, traders can apply for an up to 6 month temporary street trading licence for one of the following 3 sites below.

Sites will be granted to traders by way of a competitive interview process.

Trading fees: Monday to Friday daily charge of £27.28 and weekend daily charge £49.10. From April 1<sup>st</sup> 2024 all fees will increase by 6.99%.

Please note, these sites don't have electrical points. The use of electrical vehicles is compulsory.
