# INTERNAL SURVEYS



On Thursday 21st March and Friday 22nd March, you may have seen officers from the project team accompanying a consultant from Airev Miller with an interestina machine.

Over the 2 days the surveyor has been going into residents flats to carry out measurements of the rooms in their home and the externals of the blocks. This information will be useful in helping us assess any potential impact from the construction of the new blocks.

We have successfully managed to get data from a large number of flats thanks to the cooperation of residents.

# FREQUENTLY ASKED QUESTIONS: COURTYARDS

We have recieved a few questions from residents on how the courtyards will be designed and what they will look like in the new estate.

The courtyards will be generous in size (they will have minimum size restrictions set by the planners) and there will be soft landscaping to help mitigate sound travelling, triple-glazed windows are currently specified which can also help with this. There will be an acoustic consultant working with the design team when these designs are being developed in the future. There is also play space available publicly across the estate – for example in the pedestrianised roads running in between these blocks.

The courtyard design is a very popular and common design used across London.

The courtyard blocks are not designed in detail yet and will be submitted in 'outline' as part of the planning application, this means that further detailed assessments will be done during the future detailed design of these courtyard blocks.
